**ORDER:**

1. The RTI application is dated 27.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 01.10.2022 and the second appeal was filed in the Commission on 19.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 01.03.2023. Accordingly, the case has been heard today. Shri Satinderpal Singh, appellant comes present to attend the hearing through cisco webex. He states that no information has been supplied to him.
3. Shri Satpreet Singh, SDO Sub Division, PSPCL, Kurali comes present in person before the Bench to attend the hearing on behalf of the PIO. He states that the appellant has been supplied information vide letter dated 16.02.2023 by registered post. He also produces a copy of the same before the Bench, and also an additional copy for handing over to the appellant.
4. The appellant denies the receipt of letter dated 16.02.2023. The Bench, then directs the respondent to send the same on WhatsApp number of the appellant in the form of PDF file. After doing the needful, the respondent again reverts back to the Bench and apprises of having sent the information on WhatsApp to the appellant.
5. On the asking of the Bench, the appellant expresses dis-satisfaction over the information supplied as the copy of application of the person in whose name the earlier meter was applied for has not been supplied. He states that in addition, one odd point has also not been addressed by the respondent.
6. Post deliberations, the Bench advises the appellant to point out deficiencies in writing to the PIO and the PIO is directed to supply rectified information to the appellant, after removing the deficiencies, before the next hearing. The Bench further directs the respondent present i.e. SDO PSPCL Kurali and the SDO PSPCL Kharar to come present in person before the Bench on the next hearing and bring along the entire relevant record.
7. In view of the above, the matter is adjourned. **To come up for hearing on 09.05.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
