4. The PIO O/o Block Development and Panchayat Officer, Block Abohar, District Fazilka is also directed to retrieve the requisite information from the concerned PIO and provide it to the appellant, before the next date of hearing.

The Deemed PIO O/o Block Development and Panchayat Officer, Block Khuiya Sarwar at Abohar, District Fazilka to appear personally on the CISCO Webex and provide complete information to the appellant, before the next date of hearing, failing which after issuing a <a href="Show Cause Notice">Show Cause Notice</a>, Penalty will be imposed upon the PIO as per provisions of the RTI Act, 2005.
- 6. The Appellant is also directed to follow up his case in the Commission, failing which decision shall be taken in his absence.
- 7. The matter is adjourned to 21.06.2023 at 11:00 AM through CISCO WEBEX MEETING ID No. 158 188 4645. Both the parties are directed to come to attend the hearing accordingly. Copies of the order be sent to the parties.
