## **APPEAL CASE NO. 4817 OF 2022** **(Cisco Webex Proceedings)**

### **ORDER (FIRST HEARING):**

1. The RTI application is dated 30.05.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 12.08.2022 and Second Appeal was filed in the Commission on 13.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 01.05.2023. Due to the declaration of holiday on the eve of May Diwas (Labour Day) by the Government of Punjab, the case is adjourned to 03.05.2023.
2. The Appellant is absent. However, a letter has been received by the Bench mentioning therein information sought has not been provided to him.
3. The Respondent states that requisite information has already been supplied to the appellant.
4. The PIO is again directed to supply this information to the appellant today, under intimation to the Commission. The Appellant is advised to send deficiencies, if any, in writing to the PIO after receiving the information. The PIO is also directed to remove the deficiencies, if any, received from the appellant and supply rectified information, under intimation to the Commission, before the next date of hearing.
5. The Appellant is also directed to follow up his case in the Commission, failing which decision shall be taken in his absence.
6. The matter is adjourned. To come up for hearing on **21.06.2023 at 11:00 AM through CISCO WEBEX MEETING ID No. 158 188 4645**. Both the parties are directed to present their case accordingly. Copies of the order be sent to the parties.
