PRESENT: None for the Parties. **ORDER (FIRST HEARING):**

- 1. The RTI application is dated 30.06.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 07.09.2022 and Second Appeal was filed in the Commission on 18.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 01.05.2023. Due to the declaration of holiday on the eve of May Diwas (Labour Day) by the Government of Punjab, the case is adjourned to 03.05.2023.
- 2. The PIO is absent for today's hearing. However, the Bench has received a letter stating that information sought by the appellant is not available in the official records therefore could not be provided to him.
