4. *Pls provide reference to rule number/clause number/notification number with date based on which mobile allowance for the month of Dec 2021 was deducted.*
5. *Date on which incorrectly deducted mobile allowance (Dec 2021) was paid and transferred to my account based on my intimation dated 7<sup>th</sup> Jan 2022.*
6. *Details (letter number and date) of communication(s) sent to Dr. Ravinder Nath Bansal as reply to email dated 7<sup>th</sup> Jan 2022 and other succeeding reminders.*
7. *Application for LTC was processed and forwarded through the office of the Principal. Based on the LTC application:*
  - a. *How many days of leave was applied for?*
  - b. *How many days of station leave was applicable?*
8. *As per the records for how many days Dr. Ravinder Nath Bansal was out of station?*

2.
