**ORDER:**

1. The RTI application is dated 03.11.2020 whereby the Complainant has sought information as mentioned in his RTI application. He filed complaint in the Commission on 06.10.2021 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act). The notice of hearing was issued to the parties for 15.12.2021.
2. The aforesaid complaint case was remanded back by this Bench to First Appellate i.e. Registrar, Punjab Nursing Registration Council, Sector 69, S.A.S Nagar (Mohali) vide order dated 15.12.2021. But the complainant vide letter dated 03.03.2022 has alleged non-compliance of the orders of the Commission by the First Appellate Authority, as such this request of appellant is treated as Second Appeal.
3. On the request of the Complainant, his complaint case has been converted into Appeal Case. Accordingly, the notice of hearing was issued to the parties for 08.05.2023.
4. Advocate Randip Singh on behalf of the Respondents states that the PIO telephonically informed about the today's hearing and further requests that some more time be given to him to provide the requisite information to the appellant.
5. The Appellant states that information sought has not been provided to him.
