#### **ORDER** (FIRST HEARING):

- 1. The RTI application is dated 20.05.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 23.06.2022 and Second Appeal was filed in the Commission on 18.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 08.05.2023.
- 2. The Appellant states that information sought has not been provided to him.
- The PIO is absent for today's hearing, in spite of the Notice/Orders of the Commission. This
  shows his disregard to the Commission. The absence of the PIO is viewed seriously and it
  has also affected hearing and disposal of the case.
- 4. The perusal of the case reveals that the PIO has neither provided the complete information to the appellant nor pursue this case personally or through his representative, even after the lapse of the 11 months period.
- 5. In view of the above, a <u>SHOW CAUSE NOTICE</u> under Section 20(1) of the RTI Act is issued to the Public Information Officer O/o B.D.P.O., Block II, Moga to explain as to why penalty should not be imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
