ORDER:

1. The RTI application is dated 15.07.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.08.2022 and Second Appeal was filed in the Commission on 18.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 08.05.2023.
2. The PIO states that information as sought by the appellant is very voluminous and he is asked to inspect the official records and after deposit the documentation fee, he can get the requisite information and many letters in this regard has been sent to the appellant but he did not turn up.
3. In view of the above, last opportunity is given to the appellant to visit the office of respondent on any working day with prior appointment, inspect the relevant records, identify the documents copies whereof are required by him; and the respondent shall provide copies thereof, according to his RTI application dated 15.07.2022, on the spot, in accordance with the relevant provisions of the RTI Act, 2005.
4. LAST OPPORTUNITY is given to the appellant to follow up his case in the Commission, failing which decision shall be taken in his absence.
5. The matter is adjourned. To come up for hearing on **26.06.2023 at 11:00 AM in the Commission**. Both the parties are directed to appear personally. Copies of the order be sent to the parties.
