## **ORDER:**

- 4. <u>LAST OPPORTUNITY</u> is given to the appellant to follow up his case in the Commission, failing which decision shall be taken in his absence.
- 5. The matter is adjourned. To come up for hearing on 26.06.2023 at 11:00 AM in the Commission. Both the parties are directed to appear personally. Copies of the order be sent to the parties.
