ORDER

1. This order may be read with reference to the previous orders dated 17.11.2022 vide which respondent PIO was directed to send the sent information dated 16.11.2022 via email to the appellant within seven days after receipt of this order, under intimation to the Commission.
Appellant was advised to point out discrepancy, if any, in writing to the respondent PIO with a copy to the Commission within seven days after receipt of information via email, failing which it will be presumed that he has nothing to say in this regard. Matter was adjourned for further hearing on 14.02.2023 i.e. today.
2. In today's hearing, Sh. Harmit Singh Sidhu states that information is still pending.
3. Respondent PIO is not present but a letter no. 148 dated 20.01.2023 is received from respondent, ADC (UD), Bathinda through which he assigned duty to PIO-cum-EO, O/o Nagar Council, Rampura Phul to represent this case today but no one bothers to represent this case.
4. Respondent PIO is directed to supply the requisite information as per RTI application to the appellant within seven days after receipt of this order through registered post under intimation to the Commission.
5. Appellant is advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
7. A copy of this order be sent to respondent PIO, O/o ADC (UD), Bathinda by name to represent this case in person as he is the concerned respondent PIO in this case as per the case file.
