ORDER:

1. This case may be read with the reference to the order dated 02.03.2023 passed by this Bench on the previous hearing.
2. The case has been heard today. The appellant is absent. However, a letter dated 07.05.2023 has been received from the appellant requesting for an adjournment as he is admitted in Apollo hospital, Ludhiana for operating the Hernia. He has also mentioned that even after a lapse of more than two years, complete information has still not been received from the PIO.
3. Shri Bhupinder, Senior Assistant O/o GLADA, Ludhiana comes present in person before the Bench, on behalf of the PIO. He states that information which was available in official records has been supplied to the appellant on 11.04.2023.
4. After hearing the versions of the respondent and going through the reply of the appellant, it emerges that respondent is giving evasive replies. This attitude of the PIO is viewed adversely. Shri Divleen Singh, PIO O/o GLADA, Ludhiana is now directed to look into this matter and make sure that the order of the Bench is complied with. He is also directed to appear before the Bench in person for the next hearing and ensure that orders of the Bench passed on the previous hearing are complied with.
5. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 13.07.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
