ORDER

1. This order may be read with reference to the previous order dated 11.07.2022 passed by the Bench of Ld. SIC, Sh. Sanjiv Garg vide which last opportunity was awarded to the respondent PIO to supply the certified copies of the required information through registered post to the appellant with a copy to the Commission. The matter was fixed for further hearing on 14.11.2022. The instant appeal case was allocated to the undersigned Bench vide Office Order passed by the Hon'ble Chief Information Commissioner on 05.08.2022. Accordingly, matter is fixed for 20.10.2022 i.e. today.
2. In today's hearing the appellant is present and states that information as per RTI application is still pending to be supplied even after the directions of the Commission vide order dated 11.07.2022 even after the ample time has elapsed. He adds that he had filed a grievance at the portal of Punjab Govt. on 19.4.2020 and reminders from time to time relating to illegal construction raising on property number B04282 and B04282/1 during lock down/curfew. The video recording done in the case has been demanded vide his RTI application. He further states that nothing has been given to him till date.
3. The absence of the PIO is viewed seriously and it has also affected hearing and disposal of the case. In pursuance of this, the PIO is directed to file a written submission in response to the Order and Notice of the Commission and should present this case personally (through cisco webex), on the next date of hearing, failing which penal consequences shall follow.
4. A copy of this order be also sent to the Deputy Commissioner, Sangrur by name through **registered post** for the compliance of this order.
5. To come up on **21.12.2022 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties.
