ORDER

Major Singh by name through registered post with directions to supply the information as per previous orders of the Commission dated 13.09.2022 and 14.12.2022 with a copy to the Commission within ten days after receipt of this order. He is also directed to appear in person on the next date of hearing along with relevant record.
6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
7. Matter is adjourned for further hearing on **28.03.2023 at 11:00 A.M. at Punjab State Information Commission.** Copy of the order be sent to the parties.
