ORDER

1. This order may be read with reference to the order dated 21.09.2022 passed by this Bench on the previous hearing as the hearing scheduled for 31.10.2022 was postponed.
2. The case has been heard today. Shri Darshan Singh, appellant has not come present to attend the hearing in person before the Bench or through cisco webex. He had come present during the previous hearing, when he was informed that the hearing scheduled for 31.10.2022 has been postponed to 29.11.2022. Today, he informed through a telephonic message that he is facing difficulty in connecting through cisco webex and will be available on his mobile phone.
3. Shri Arun Kumar, Assistant Town Planner, Municipal Corporation, Amritsar comes present to attend the hearing in person before the Bench. He states that the appellant has sought information regarding a complaint made in respect of House No.4059, Gurbaksh Nagar, Jhabbal Road, Amritsar as to how much fine has been imposed on owner for not getting the plan (Naqsha) approved. He further states that he had visited the site and reply has been given to the appellant vide letter dated 28.10.2022 and has also been informed of the fine imposed after making assessment in the case under reference.
4. Shri Darshan Singh, appellant is contacted on his mobile phone. He is made to talk to the respondent Shri Arun Kumar who explains to him the details of information supplied. Then the Bench talks to the appellant. However, the appellant does not agree with the version of the respondent.
