**ORDER**

pending and the information in relation to point number 1,2,3 and 5 has been received by him. Shri Ajay

Kumar, JE submits a copy of information to the bench of undersigned during the hearing, which is taken

on record.

3. Shri Gurmej Lal, appellant is absent without any intimation to the Commission. He has neither

come present to attend the hearing in person before the Bench nor through cisco webex nor he has

deputed any representative to attend the today's hearing on his behalf.

4. Post deliberations and examination of documents on file, the Bench finds that point wise

information has been provided to the appellant, Shri Gurmej Lal. As such the bench is satisfied with the

information provided.
