### Appeal Case No. 111 of 2022 (Video Conference Proceedings)

1. The RTI application is dated **9.6.2021** vide which the appellant has sought information:

*“1) ਉਪਰੋਕਤ ਨੰਬਰ PB-2920074 ਨਾਲ ਸਬੰਧਤ ਰਿਕਾਰਡ ਦਿੱਤਾ ਜਾਵੇ ਕਿ ਉਕਤ ਨੰਬਰ ਬੇਲੀ ਵਿੱਚ ਕਿੰਨੇ ਦੇ ਲਿਆ ਗਿਆ ਅਤੇ ਇਸ ਸਮੇਂ ਕਿਸ ਵਾਹਨਾਂ ਤੇ ਲੱਗਾ ਹੈ ਇਸ ਨਾਲ ਸਬੰਧਤ ਫਾਇਲ ਦੀ ਫੋਟੋ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।”*

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **22.7.2021** and Second Appeal was filed in the Commission on **11.12.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **17.6.2022**.

2. Both the parties are absent. As directed by the Commission at the last hearing on 17.6.2022 the requested information was supplied to the appellant vide Letter No. 141 Dated 23.6.2022. Since then, no communication has been received from the appellant, which compels the Commission to conclude that the information furnished by the Respondent PIO is satisfactory.

3. This Appeal is accordingly **Disposed of**.
