## ORDER

- 5. After hearing both the parties and examining the case file, it is also observed that order date was mentioned as 13.09.2022 instead of 22.11.2022 in the order passed by the undersigned Bench in the present case on 22.11.2022, which may be read as 22.11.2022.
- 6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
