as enumerated in his RTI applications. First Appeals were filed with the First Appellate Authority (FAA) on **20.12.2021** and Second Appeal was filed in the Commission on **4.3.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **22.9.2022**.

2. The respondent PIO is absent. This is despite the Show Cause Notice issued to him vide this Commission's Order of 22.9.2022. He has however, submitted a reply to the appellant vide Letter No. 1321 Dated 2.11.2022, furnishing the requested information by way of property tax receipts of private hospitals, schools, etc. The appellant has confirmed that he has received said reply along with the information. This Appeal is accordingly **Disposed of**.
