**ORDER:**

The PIO is also directed to supply the information to the Appellant by hand or send the specific identified record to the Appellant within seven days from the date of inspection as per RTI application, failing which stern action would be initiated against the concerned respondent PIO.
6. If the Appellant, Sh. Ravinder Pal Singh will not visit for inspection on the said date and time then it would be presumed that he does not requires the information anymore and the case would be decided on merits.
7. The PIO is also directed to submit a reply to the Show cause notice which was issued to the concerned PIO on hearing held on 28.09.2022.
8. Matter is adjourned for further hearing on **26.07.2023 at 11:00 A.M. through CISCO WEBEX.** Copy of the order be sent to the parties.
