ORDER

1. This order may be read with the reference to the order dated 06.02.2023 passed by this Bench on the previous hearing vide which penalty of Rs. 10,000/- was imposed on the PIO.

4. It also transpires that no information has been supplied to the appellant. It is clear that he does not have any respect for the statutory institution. The Commission cannot take it lying down. The matter has to be taken to a logical end.

While exercising its authority under Section 18 (3) (a) of the RTI Act, 2005, a bailable warrant is issued against Sh. Gurjaspreet Singh, Astt. Registrar Cooperative Societies Bhatinda with the direction to the SSP Bhatinda to serve it on him to appear along with entire relevant record, before the Bench in the Punjab State Information Commission at Chandigarh on 26.06.2023 at 11:30 AM, so that appropriate action is taken against him.
