ORDER

- 1. This order may be read with reference to the previous order dated 13.10.2022.
- 2. In today's hearing, appellant is present and states that information is still pending from the respondent.
- 3. Respondent, Ms. Suman Lata states that information in connection with RTI application was sent to the appellant on 03.02.2022 through registered post, which was received by the appellant. She adds that as per the order passed by the Hon'ble Chief Information Commissioner vide order dated 19.05.2022, information in connection with point no. 7 and 8 was again sent to the appellant through registered post dated 16.06.2022 and till date no discrepancy has been pointed out by the appellant in the supplied information on 03.02.2022 and 16.06.2022.

She further adds that information was sent to the appellant third time on 27.10.2022 as per the order passed by the undersigned Bench on 13.10.2022, which was refused by the appellant and returned to the office stating therein to send via email.

She also mentions that a reply in this regard is sent to the Commission vide letter no. 878 dated 06.12.2022, which is received in the Commission vide diary no. 28083 dated 06.12.2022 and taken on record.

4. After having detailed discussion with both the parties in detail and examining the case file, it is observed that no deficiency has been pointed out by the appellant in the supplied information, which were received by him through registered post dated 03.02.2022 and 16.06.2022, which means he has nothing to say in this regard.
