**ORDER:**

1. The RTI application is dated 20.10.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 01.12.2022 and the second appeal was filed in the Commission on 06.02.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today. As per appellant, he has not been provided any information so far.
3. As per respondents, no document relating to Pharshi Kandas installed if any within the jurisdiction of NC Garghshankar is available in their record. However, they are getting a survey done and assure to provide information to the appellant once the survey is complete. The respondent during his submission has asked for adjournment and another date to enable them to compile and get the survey done.
4. The adjournment is granted. The PIO is directed to get the survey done and provide information to the appellant before the next hearing.
