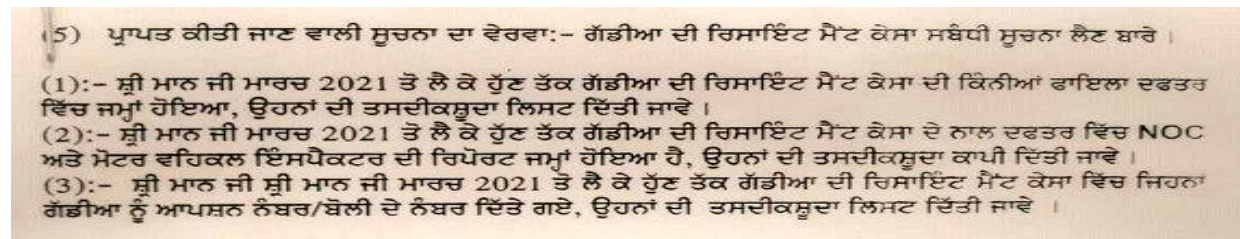

1. The RTI application dated **2.12.2021** vide which the appellant has sought information:



as enumerated in his RTI applications. First Appeals were filed with the First Appellate Authority (FAA) on **17.1.2022** and Second Appeal was filed in the Commission on **7.3.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **23.9.2022**.

2. Both parties are Absent. At the hearing on 30.6.2022, the respondent PIO was issued a Show Cause Notice. The respondent PIO has submitted a reply to said Show Cause Notice vide Letter No. 678 Dated 23.9.2022, wherein, she has attributed the delay in furnishing the requested information to the State Assemble Elections. She has however, reiterated that the requested information, by way of a pointwise reply, was sent to the appellant vide letter No. MTP/649 Dated 12.8.2022. A copy of the same has also been received in the Commission. In an email Dated 20.11.2022, the appellant Sh. Jasbir Singh, however, still maintains that he has not received any reply/information from the respondent PIO. The appellant can collect copy of the respondent PIO's reply/information which is available on the case file, from the office of this Bench on any working day.
