ORDER:

The appellant, through an RTI application dated 09.09.2021 has sought certified copies of entire indents/requirements received from the office of Chemical Examiner to Pb Govt Kharar against which purchase orders for Lab chemicals were placed by office of Director Health in rate contract No.15919 dated 08.11.2010 for chemical examiner to Pb Govt – copy of entire stock book entris of Silvere Nirate in both 100 gms and 500 gms packing as per official record of chemical examiner to Pb Govt from 01.10.2010 till 09.09.2021 – copy of stock book of silver sulphate in 25 gm packing as per record of chemical examiner to Punjab Govt from 01.10.2010 till 09.09.2021 as enumerated in the RTI application from the office of Director Health,(C/o Dy. Director Stores) Pb Chandigarh. The appellant was not satisfied with the reply of the PIO dated 25.10.2021 after which the appellant filed a first appeal before the First Appellate Authority on 09.11.2021, which did not decide on the appeal.

The case has come up for hearing today through video conferencing at DAC Ludhiana. As per respondent, the information has been provided.

As per the appellant, the information is incomplete.

Having gone through the RTI application and hearing both the parties, the following is concluded:
