2. **Written submission from respondent PIO Sh. Charanjit Singh , Panchayat Secretary:**  
 An email 13.10.2022 is received by the undersigned bench the relevant portion of which is reproduced below:  
 "..ਉਪਰੋਕਤ ਵਿਸ਼ੇ ਦੇ ਸਬੰਧ ਵਿਚ ਆਪ ਨੂੰ ਲਿਖਿਆ ਜਾਂਦਾ ਹੈ ਕਿ ਆਪ ਵੱਲੋਂ ਪਿੰਡ ਰੋਸ਼ਨਪੁਰ ਪੱਤੀ ਝੁੰਗੀਆਂ ਦੇ ਖਸਰਾ ਨੰ: 387, 0-18 ਗੈਰ ਮੁਮਕਿਨ ਅਬਾਦੀ ਤੇ ਕਬਜ਼ੇਦਾਰ ਦੇ ਪਤੇ ਦੀ ਮੰਗ ਕੀਤੀ ਗਈ ਸੀ। ਜਿਸ ਲਈ ਦਫਤਰ ਬਲਾਕ ਵਿਕਾਸ ਤੇ ਪੰਚਾਇਤ ਅਫਸਰ ਭੁਨਰਹੇਰੀ ਦੇ ਪੱਤਰ ਨੰ 3407 ਮਿਤੀ 29/9/2022 ਨੂੰ ਤਹਿਸੀਲਦਾਰ ਦੁਧ ਸਾਧਾਂ ਜੀ ਨੂੰ ਨਿਸ਼ਾਨ ਦੇਹੀ ਲਈ ਲਿਖਿਆ ਗਿਆ ਹੈ। ਇਸ ਲਈ ਨਿਸ਼ਾਨ ਦੇਹੀ ਹੋਣ ਉਪਰੰਤ ਆਪ ਨੂੰ ਤਾਲ-ਮੇਲ ਕਰਕੇ ਤਹਿਸੀਲਦਾਰ ਦੁਧਣ ਸਾਧਾਂ ਪਾਸੋਂ ਜਾਣਕਾਰੀ ਲਈ ਜਾਵੇ।"
3. Appellant, Shri Jarnail Singh stated that no information has been supplied to him so far by the respondent authority.
4. In view of the harassment and detriment caused to the appellant, Shri Jarnail Singh, this Commission deems it appropriate to award a compensation of Rupees Ten

Thousand (Rs. 5000.00). This is to be paid by the Public Authority, in this instance, the Panchayat Secretary, Gram PanchayatRoshanpur Patti, Jhugia, Block Bhunerheri, District Patiala, within 15 days of receiving this order.
