ORDER

1. This order may be read with the reference of the order dated 05.12.2022 passed by this Bench on the previous hearing.
2. The case has been heard today Shri Sukhdhir Singh Sekhon, appellant has not come present in person before the Bench or through cisco webex. He informed through a telephonic message that information on point No.3 has not been supplied to him.
3. Shri Amit Kumar, Senior Assistant, O/o GLADA, Ludhiana comes present to attend the hearing in person before the Bench and states that the information as available in the official records has been supplied to the appellant and nothing beyond that is available in the records relating to RTI application of the appellant.
4. Since the appellant is absent, the Bench contacts him on his mobile phone. He is made to talk to the respondent who explains to him the information supplied. Then the Bench talks to him and apprises him that he has been provided information by the respondent as available in the official records. He then requests that he may be given in writing by GLADA to this effect.
5. Post deliberations, the PIO O/o GLADA, Ludhiana is directed to file an affidavit on e-stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.1264/2022 has been supplied to the appellant. It is be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.
6. In view of the submissions made in writing by the respondent before the Bench, the show cause notice is dropped.
7. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
