**ORDER**

1. This order may be read with reference to the order dated 15.12.2022 passed by this Bench on the previous hearing. The case has been heard today in the Commission's office at Chandigarh.
2. Shri Sunil Sharma, XEN/PIO comes present in person before the Bench and states that point-wise reply has been given to the appellant vide letter dated 30.12.2022. He further states that the information as existing in the official records relating to Gyms stands supplied in the appeal case.
3. Shri K.N.S. Sodhi, appellant also comes present in person before the Bench and acknowledges the receipt of letter dated 30.12.20-22 from the PIO.
4. The appellant, during his submissions, highlights corruption in the installation of Gyms in the parks of Municipal Corporation, S.A.S. Nagar (Mohali) and states that Gyms are existing only on paper and there is nothing on the ground. He alleges corruption by Shri Kamaldeep Singh, XEN in the non-execution of the works. He further highlights the role of Smt. Avneet Kaur, XEN who was the PIO, Municipal Corporation, SAS Nagar (Mohali) during December, 2021 in not providing the information and protecting the official responsible for embezzlement of funds.

5. The Bench, post deliberations, directs the present Executive Engineer Shri Kamaldeep Singh and the previous Executive Engineer, Municipal Corporation, SAS Nagar(Mohali), Smt. Avneet Kaur to come present before the Bench on the next hearing to clarify the position regarding such laxity in execution of development works as also delaying the provision of information to the appellant, as alleged by the appellant.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 08.02.2023 at 11.30 am before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
