ORDER

1. This order may be read with reference to the order dated 30.11.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Tejinder Singh, appellant comes present to attend the hearing in person before the Bench. He states that the action taken report on his complaint has not been provided to him so far.
3. Shri Narinder Singh, Senior Assistant, O/o GLADA Ludhiana comes present to attend the hearing on behalf of Shri Bhupinder Singh. He, however, states that he is not fully aware of the facts of the case and he will apprise the concerned official Shri Bhupinder Singh of the proceedings of the hearing.
4. The Bench observes that the PIO has deposited the amount of penalty of Rs.5000/-. However, it has not been apprised of as to whether copy of complaint No.9294/2020 as requested from the appellant has been received or not. The Bench directs the appellant to send a copy of said complaint to Shri Bhupinder Singh, Senior Assistant on his mobile No.98148-22881, if not sent earlier.

5. The Bench also directs the PIO to coordinate with the appellant to get copy of the complaint and supply information regarding action taken report on the said complaint to the appellant before the next hearing. The PIO is also directed to ensure to come present in person before the Bench, along with Shri Bhupinder Singh, Senior Assistant, on the next hearing.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 02.03.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh.** Copies of the order be sent to the concerned parties.
