1. The RTI application is dated **9.11.2021** vide which the appellant has sought information as under:-

*A. Certified copies of rules, terms and condition to be followed by allottee for use of allotted plots under Kartar Singh Sarabha Nagar scheme by Ludhiana Improvement Trust.*

*B. Certified copy of format for declaration and affidavits, taken from applicants of plot to whom plots were allotted by Ludhiana Improvement Trust at kartar Singh Sarabha Nagar scheme, Ludhiana.*

*C. Certified copies of format of allotment letter for giving allotment to allottee/applicant of plot to whom plots are allotted by Ludhiana Improvement Trust.*

*D. Certified Copies of allotment letter issued to house number J-8 and J-9 of Kartar Singh Sarabha Nagar, Ludhiana by Improvement Trust during allotment of plot.*

*E. Certified copies of letters/orders by which Kartar Singh Sarabha Nagar scheme area was handed over to Municipal Corporation, Ludhiana with all the attachments/annexures by Ludhiana Improvement Trust.*

*F. List of person with addresses to whom NOC has been given for change of land use in Kartar Singh Sarabha Nagar scheme area by Ludhiana Improvement Trust till date."*

enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **18.12.2021** and Second Appeal was filed in the Commission on **17.3.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **30.8.2022**.

2. The appellant is absent without intimation. As directed at the last hearing on 30.8.2022, the respondent PIO, represented at today's Hearing by Ravinder Kumar, Clerk, has submitted a fresh pointwise reply along with the requested information, a copy of which has also been supplied to the appellant.
