ORDER

1. This order may be read with reference to the order dated 30.11.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Rajesh Kumar, appellant comes present to attend the hearing in person before the Bench. He states that he has not been supplied any information so far.
3. Shri Ravneet Singh, Executive Officer, Municipal Council, Zirakpur comes present to attend the hearing in person before the Bench along with Shri Gulshan Mehta, Advocate who produces before the Bench Memo of Appearance to appear on behalf of Municipal Council, Zirakpur. He states that RTI was addressed to GMADA, Mohali and Municipal Council, Zirakpur has been impleaded as respondent. He further

states that the complaint made by the appellant to the Chief Secretary, Punjab has been received vide letter dated 02.01.2023 by GMADA which is not legible and the requisite information could not be supplied. He requests to ask the appellant to provide him a legible copy of the complaint. He also produces before the Bench the reply to the show cause notice.

4. In view of the reply submitted by the PIO, the show cause notice is dropped. As requested by him, the Bench advises the appellant to make available a legible copy of the complaint made by him to the Chief Secretary, Punjab.

5. Thereafter, on finding copy of the complaint available in the case file, copy of the same is handed over to the PIO. The Bench directs the PIO O/o Municipal Council, Zirakpur to supply information relating to action taken report to the appellant as also to ensure to come present in person before the Bench on the next hearing.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 02.03.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
