4. Shri Om Bahadur, Senior Assistant attends the hearing in person before the Bench on behalf of the PIO and states that the RTI application has been transferred to PIO Municipal Council, Zirakpur who has been impleaded as respondent in the instant case

6. The Bench directs the PIO O/o Municipal Council, Zirakpur to supply information to the appellant as also to ensure to come present in person before the Bench on the next hearing.
