ORDER:

The appellant, through an RTI application dated 29.10.2021 has sought information regarding action taken report on emailed letter dated 13.10.2021 – how much area of any flats and homes situated in Pb Jurisdiction can be used for commercial purpose – area indulged in Pb. Land Record system in Dera Bassi & Zirakpur and prescribed Govt fee for fard mutation – Govt notification regarding property of residential tax slabs as enumerated in the RTI application from the office of Principal Secretary Local Govt. Pb Chandigarh. The appellant was not provided the information after which the appellant filed a first appeal before the First Appellate Authority on 03.11.2021, which did not decide on the appeal.

The case has come up for hearing today. Sh.Gurpreet Singh, building inspector present from Town Planning Wing informed that the information on point 1 & 2 has been provided to the appellant vide letter dated 23.11.2021, the information on point-3 relates to the office of the FCR and the information on point 4 & 5 relates to LG-3 Branch. The RTI application relating to point 4 & 5 has been transferred to LG-3 Branch.

The respondent present from LG-4 Branch of Local Govt pleaded that the information on point 5 (copy of notification dated 25.08.2021) has already been provided vide letter dated 18.10.2022 but the information on point-4 has to be provided by LG-3 Branch.

The appellant is absent nor is represented.

The PIO-Town Planning Wing, Dept of Local Govt. Pb is directed to transfer the RTI application relating to point-3 to the PIO-Financial Commissioner, Revenue and collect information on point-4 from the concerned PIO and send the same to the appellant. The PIO-Financial Commissioner, Revenue to provide information on point-3 to the appellant with a copy to the Commission.

With the above order, the case is **disposed of and closed.**
