

ORDER:

- 1. The RTI application is dated 14.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 06.10.2022 and the second appeal was filed in the Commission on 17.02.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The case has been heard today. The appellant is absent. The appellant is contacted on his mobile and he states that he has not been provided any information so far.
- 3. As per respondent, since the information relates to the office of Superintending Engineer, Punjab Water Supply and Sewerage Board, Amritsar and Improvement Trust Amritsar, the RTI application has been transferred to them vide letter dated 18.10.2022 with a copy to the appellant.
- 4. The PIO O/o Superintending Engineer, Punjab Water Supply and Sewerage Board, Amritsar and the PIO-Improvement Trust, Amritsar are impleaded in the case and directed to look at the RTI application transferred by the office of Xen(O&M) MC Amritsar on 18.10.2022 and provide point-wise information to the appellant. The PIO O/o Superintending Engineer, Punjab Water Supply and Sewerage Board, Amritsar and PIO-Improvement Trust, Amritsar are further directed to come present in person before the Bench on the next date of hearing alongwith relevant record. The appellant is also directed to appear before the Bench in person on the next hearing.
- 5. With the aforesaid directions, the matter is adjourned. To come up for hearing on 12.07.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh. Copies of the order be sent to the concerned parties.
