The Drawing and Disbursing Officer O/o District Development & Panchayat Officer, Jalandhar is directed to deduct the amount of penalty of Rs. 10000/- from the salary of PIO O/o District Development & Panchayat Officer, Jalandhar and deposit in the State Treasury in the following Head of Account and to report its compliance to the Commission: -
