ORDER (THIRD HEARING):

In view of the above, a **SHOW CAUSE NOTICE** under Section 20(1) of the RTI Act is issued to the Public Information Officer – cum – Panchayat Secretary, Gram Panchayat Threke Colony, Block Ludhiana, District Ludhiana to explain as to why penalty should not be imposed upon him/her for wilful delay/denial in supplying the information to the RTI appellant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.

Last & Final Opportunity is given to the PIO to file reply to the Show Cause Notice and provide complete information to the appellant within week, under intimation to the Commission and should appear personally in the Commission, on the next date fixed, failing which Rs. 25000/- penalty will be imposed upon him/her as per provisions of the RTI Act, 2005.
7. Last opportunity is also given to the Appellant to follow up his case in the Commission failing which decision shall be taken on his absence.
8. The matter is adjourned. To come up for hearing on **19.04.2023 at 11:30 AM in the Commission**. Both the parties are directed to present their case personally. Copies of the order be sent to the parties.
