ORDER

1. The RTI application is dated 9.9.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 20.10.2022 and second appeal was filed in the Commission on 19.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 3.5.2023 i.e. today.
2. In today's hearing, both the parties are present.
3. The appellant states that he has sought information vide his RTI application dated 9.9.2022 with regard to supply the fitness certificate of the vehicles. He further adds that nothing has been supplied to him.
4. The respondent states that reply was sent to the appellant through letter no. 880 dated 15.03.2023. The court asks whether the reply sent to the appellant was ordinary or registered post. The respondent states the reply was sent through ordinary post.
5. After hearing both the parties in detail, the court directs the respondent PIO to supply the reply by registered post under intimation to the Commission immediately. The appellant is also advised to point out deficiencies, if any, on receipt of the information within 7 days with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
7. With the aforesaid directions, **the matter is adjourned for further hearing on 21.06.2023 at 11:00 A.M. through CISCO-Webex (Video Conferencing application)**. Copy of the order be sent to the parties.
