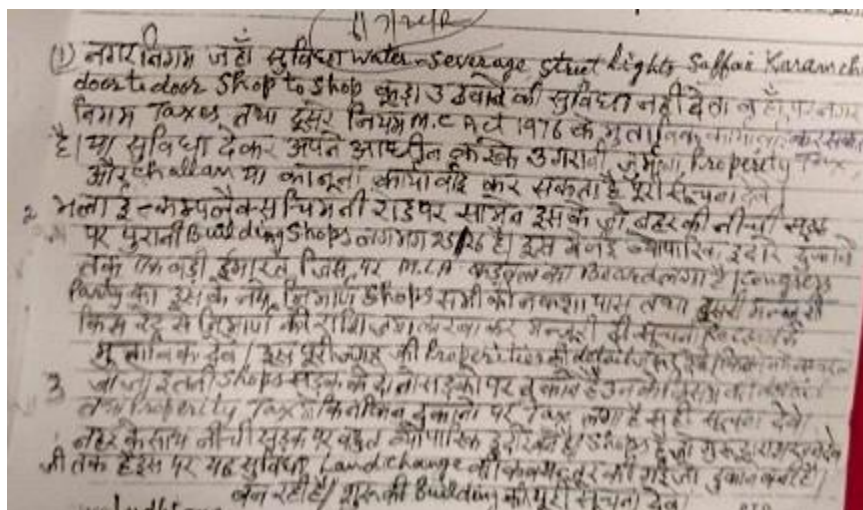

## **Appeal Case No. 1572 of 2022 (Video Conference Proceedings)**

2. Both parties are present. The respondent PIO submitted a copy of the reply sent to the appellant by the Building Branch vide Letter No. 974 Dated 3.12.2021, wherein the appellant was informed that Building cited in the RTI application is not specific and he has been requested to provide more specific details, including photographs, of cited building. It is notable that the respondent PIO's reply was sent within the stipulated 30 day period.

3. Also submitted to the Commission is a copy of a reply sent by the PIO, O&M Cell, Zone C vide Letter No. 98 dated 4.10.2022 wherein the appellant has also been requested to provide the property number of the property cited in the RTI application to obtain the requested information. No reply / information has been supplied by the Property Tax Branch pertaining to point No. 3 of the RTI application. The PIO, Property Tax Branch, Zone-C, represented by Sh. Chand Gill, Clerk, is directed to furnish a written reply to the appellant within 20 days of receipt of this order.

4. The appellant is meanwhile, advised to provide more specific details of the property cited in his RTI application as requested by the PIO, Building Branch, Zone-C and PIO, O&M Cell, Zone-C. Following this, the aforesaid PIOs are to provide written replies along with duly attested copies of the requested information. This must be done within 20 days of receipt of the specific details (property number, photographs etc.) from the appellant.

5. This Appeal Case is accordingly **Disposed of.**
