

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **14.1.2022** and Second Appeal was filed in the Commission on **1.4.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **12.12.2022**.

- 2. The appellant is absent but has informed the Commission of his inability to attend this hearing. At the last hearing on 12.12.2022, the PIO-cum-Municipal Engineer incumbent on the date of submission of this RTI application i.e. 7.12.2021, Sh. Sukhwinder Singh was issued a Show Cause Notice to which he has submitted a written reply Dated 11.1.2022. Along with said reply, he appended copy of reply to the RTI application vide Letter No. 1042/C Dated 15.12.2021, wherein the appellant was invited to inspect the record in the office of MC, Moga. As per Sh. Sukhwinder Singh, the appellant however, did not come for said inspection.
- 3. It is also mentionable here that the appellant has since refused to conduct any physical inspection in the office of Municipal Corporation, Moga. Under the circumstances, the Commission deems it fit to **Dispose of this Appeal**.
