*(To be read in continuity with earlier orders on **21.9.2022, 10.11.2022, and 12.12.2022**)*

1. The RTI application is dated **31.12.2021** vide which the appellant has sought information **regarding Civil Branch, MC, Moga**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **1.2.2022** and Second Appeal was filed in the Commission on **1.4.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **12.12.2022**.
2. The appellant is absent but has informed the Commission of his inability to attend this hearing. The respondent PIO incumbent on the date of this RTI application was submitted i.e. 31.12.2021, Sh. Sukhwinder Singh, was issued a Show Cause Notice vide this Commission's Order of 12.12.2022.
3. Sh. Sukhwinder Singh appeared in person and submitted that he demitted his post as Municipal Engineer-cum-PIO, MC Moga on the same day of this RTI application was filed i.e. 31.12.2021.
4. The Commission hereby directs the incumbent PIO-cum-Municipal Engineer, Sh. Ekjot Singh, to submit a list of PIOs since 31.12.2021. This must be done forthwith.
