### ORDER

This order may be read with reference to the previous order dated23.1.2023.

2. The appellant has sought the following information as per his RTI application:-

(ਅ) ਸਮੇਂ ਸਿਰ ਨਾਲ ਇਹ ਸੂਚਨਾ ਸਬੰਧ ਬੰਦੀ ਹੈ।  
(ਬ) ਭੋਜਪੁਰੀ ਸੂਚਨਾ ਦਾ ਵੇਰਵਾ (i) ਪਿੰਡ ਬਲਿਮਾਣ ਪੁਰ ਦੇ ਸਾਲ 2016 ਤੋਂ ਸਾਲ 2019 ਤੱਕ ਪ੍ਰਦਾਨ ਕੀਤਾ ਗਿਆ ਹੈ।  
(ii) ਪਿੰਡ ਬਲਿਮਾਣ ਪੁਰ ਦੇ ਸਾਲ 2016 ਤੋਂ ਸਾਲ 2019 ਤੱਕ ਸਿਰਫ਼ ਭੋਜਪੁਰੀ ਸੂਚਨਾ ਦੇ ਬਾਰੇ ਹੀ ਪਤਾ ਲੱਗਿਆ ਹੈ।  
(iii) ਪਿੰਡ ਬਲਿਮਾਣ ਪੁਰ ਦੇ ਸਾਲ 2016 ਤੋਂ ਸਾਲ 2019 ਤੱਕ ਪ੍ਰਦਾਨ ਕੀਤੀ ਸਾਰੀ ਸੂਚਨਾ ਦੇ ਬਾਰੇ ਹੀ ਪਤਾ ਲੱਗਿਆ ਹੈ।

3. The respondent-Public Information Officer handed over an affidavit to the appellant in this case as per the directions of the Commission. After going through an affidavit, the appellant submits that he has no objection, if the present case is disposed of. A copy of the said affidavit is taken on record. Sh. ParshotamLal, Panchayat Secretary-cum-Public Information Officer also made the oral submissions and also tenders unconditional apology regarding delay occurred in this case due to unforeseen situation. Also, he has requested to withdraw the show cause notice issued to him. Keeping in view the submissions made by the respondent, the show cause notice issued to him is hereby withdrawn.

4. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
