ORDER

1. The RTI application is dated 10.11.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 12.12.2022 and second appeal was filed in the Commission on 02.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 04.05.2023 i.e. today.
3. In today's hearing, respondent, Sh. Balkar Singh states that reply was sent to the appellant on 20.02.2023 and information could not be supplied being third party information.
4. On this, appellant states that he has received reply dated 20.02.202 along with letter dated 14.02.2023 from department through which department demanded information from him regarding names of beneficiaries along with their father names, which was submitted to Sh. Gurmeet Singh Superintendent by hand in the following format:
