ORDER:

- The RTI application is dated 01.10.2022 vide which the appellant has sought information 1. as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 16.11.2022 and the second appeal was filed in the Commission on 01.03.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- The case has been heard today. As per respondent, they received the RTI application on 2. 03.10.2022 and reply was sent to the appellant vide letter dated 28.10.2022 stating that since as per report of incharge, PC Branch, the enquiry is pending, the information cannot be provided. Thereafter, the appellant filed first appeal before the First Appellate Authority on 16.11.2022 and since the enquiry was still pending with Chief Officer, Police Station, C-Division Amritsar, the reply was sent to the appellant vide letter dated 21.12.2022. Now as per report of PC branch, the enquiry has been completed and the information as available in the official records has been provided to the appellant vide letter dated 21.03.2023. The Commission has also received a copy of information from the PIO on 24.04.2023 which is taken on record.
- 3. The appellant however raises some issues about different dates in the replies forwarded by the PIO in the first instance which the respondent clarified in detail to the appellant during the hearing. The Commission has also received observations of the appellant on 19.05.2023 which is taken on record.
- Having gone through the RTI application, copy of reply/information received from the PIO and observations of the appellant, the Bench finds that the RTI application has been sufficiently replied to and no further interference of the Commission is needed.
- The case is **disposed off and closed.** Copies of order be sent to both the parties. 5.
