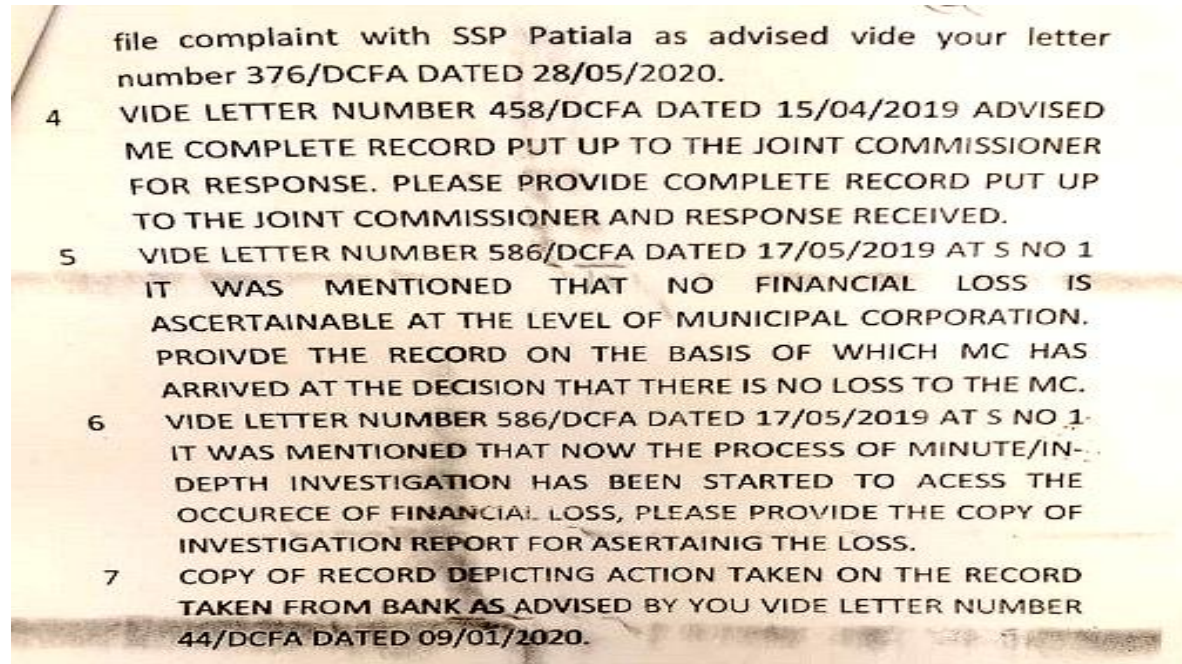

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **11.2.2021** and Second Appeal was filed in the Commission on **26.3.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **2.11.2022**.

2. The appellant is absent. As directed at the last hearing on 2.11.2022, the respondent PIO-cum-DCFA, Sh. Neeraj Raheja, has resubmitted the original affidavit along with the attested copies of the information. This was received in the Commission vide Diary No. 25842 Dated 10.11.2022.

3. Meanwhile in an email Dated 3.12.2022, the appellant has requested that the affidavit and information be sent to him by post since he is out of station and cannot attend today's hearing.
