1. The RTI application is dated **21.12.2021** vide which the appellant has sought information **regarding letter no. SS/CVO-2021/2239 Dated 22.6.2021 and SS/CVO-2021/3009 Dated 16.8.2021**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **25.1.2022** and Second Appeal was filed in the Commission on **5.4.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **17.11.2022**.

2. The appellant is absent for the second successive hearing. The respondent PIO, represented by Sh. Vaneet Kumar, SDO, B&R, Zone-D, has submitted a copy of reply sent to the appellant vide Letter No. 186 Dated 8.12.2022, wherein it is stated that the requested information is not available in the office of B&R, Zone-D.

3. The Commission has re-examined the RTI application which seeks the action taken on two letters received in the office of Commissioner, MC, Ludhiana from the CVO, Local Bodies. The information pertains to action on complaints against B&R Branch Officers of all 4 Zones, and any action taken, should be available with the office of Commissioner, MC, Ludhiana.

4. The PIO-cum-Superintendent, Headquarters, is directed to reexamine this RTI application along with appended Complaint and file a suitable reply before the next hearing.
