**ORDER**

1. This order may be read with reference to the previous order dated 17.11.2022 vide which respondent PIO was directed to send information via email and registered post to the appellant within seven days after receipt of that order, under intimation to the Commission.

Appellant was advised to point out discrepancy, if any, in writing to the respondent PIO with a copy to the Commission within seven days after receipt of information via post/email, failing which it will be presumed that he has nothing to say in this regard. Matter was adjourned for further hearing on 14.02.2023 i.e. today.

2. In today's hearing, appellant states that incomplete information has been supplied to him by the respondent PIO. He further adds that has sent letter dated 24.01.2023 in this regard to the Commission (vide diary no. 2674 dated 27.01.2023), which is seen and taken on record.
3. Respondent PIO is not present but an email dated 23.11.2022 and a reply vide letter no. 3475 dated 22.11.2022 (vide diary no. 24147 dated 24.11.2022) along with supporting documents are received by the undersigned Bench, which are seen and taken on record.
4. After examining the documents placed on record, respondent PIO is directed to remove discrepancy as per RTI application and represent this case on the next date of hearing to clear the facts of this case so that case could be concluded positively. A copy of this order be sent to him along with copy of discrepancy letter dated 24.01.2023 be sent to him for his ready reference.
5. Appellant is advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
