6. The PIO O/o Panchayat Secretary, Gram Panchayat Lahri, Block Gharota, Tehsil and District Pathankot is also directed to retrieve the remaining information from the concerned department and supply to the appellant, before the next date of hearing.
7. The PIO O/o XEN/Executive Engineer, Water Supply & Sanitation Department, Pathankot is directed to supply information as sought by the appellant, under intimation to the Commission, before the next date of hearing.
8. **LAST & FINAL OPPORTUNITY** is given to both the PIOs O/o Panchayat Secretary, Gram Panchayat Lahri, Block Gharota, Tehsil and District Pathankot & the PIO O/o XEN/Executive Engineer, Water Supply & Sanitation Department, Pathankot to provide the requisite information to the appellant, before the next date of hearing. In case the information as sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which **PENALTY** will be imposed upon both the PIOs as per provisions of the RTI Act, 2005.
9. To come up for hearing, the case is adjourned to **19.04.2022 at 11:30 AM in the Commission**. Both the parties are directed to present their case personally. Copies of the order be sent to the parties
