ORDER:

- 1. The RTI application is dated 05.12.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 11.01.2023 and the second appeal was filed in the Commission on 07.03.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The case has been heard today. The appellant comes present in person and states that no information has been provided by the PIO so far.
- 3. The PIO is absent and is also not represented. There is nothing on record which shows that the RTI application has been attended to within the time prescribed under the RTI Act and there has been an enormous delay of more than five months in providing the information. The Commission has taken a serious view of this and hereby directs the PIO to show cause why penalty be not imposed on him under section 20 of the RTI Act 2005 for not supplying the information within the statutorily prescribed period of time. He/she should file an affidavit in this regard. If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such person(s) of the show cause and direct them to appear before the Commission along with the written replies.
- 4. The PIO is directed to provide point-wise information/reply to the appellant relating to his complaints dated 08.04.2022 followed by reminder dated 05.07.2022 & 03.10.2022 before the next hearing. The PIO is also directed to come present in person before the Bench to attend the next hearing.
- 5. With the aforesaid directions, the matter is adjourned. To come up for hearing on 12.07.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh. Copies of the order be sent to the concerned parties.
