**ORDER:**

1. This order may be read with reference to the order dated 01.06.2023 passed by this Bench during the previous hearing.
2. The case has been heard today. The appellant comes present in person and states that even after a lapse of seven months, no information has been provided by the PIO.
3. Shri Khushveer Singh, Sr. Assistant comes present in person from the O/o Housing and Development and states that action on the complaint dated 08.04.2022 of the appellant is to be taken by the Higher Authorities of GLADA, Ludhiana. They are the competent authority.
4. Neither the PIO O/o GLADA, Ludhiana has come present to attend the hearing through Cisco Webex nor he has deputed any of his representatives to attend the hearing. However, an email dated 12.07.2023 has been received in the Bench from the respondent o/o GLADA, Ludhiana mentioning therein that reply to the effect has already been sent to the appellant vide letter dated 24.01.2023 that action on the complaint dated 08.04.2022 is still under process and no action has been taken by the higher authorities yet.
5. The appellant is apprised the version of the respondent but he denies and states that no such written reply has been received from the department. Post deliberations, the PIO is now directed to convey the final status report of the complaint dated 08.04.2023 to the appellant as soon as it is finalized with a copy to the Commission.
6. With the above said directions, no cause of action is left in the instant appeal case. The case is **disposed off and closed**. Copies of the order be sent to the parties.
