ORDER

1. The RTI application is dated 14.10.2021 vide which the appellant has sought information as enumerated in his RTI application and the second appeal was filed in the Commission on 31.03.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The aforesaid complaint/appeal case was remanded back by this bench to First Appellate Authority i.e. AEO, Jalandhar Development Authority, Jalandhar vide order dated 19.07.2022. But the appellant vide email dated 27.08.2022 has alleged non compliance of the orders of Commission by the First Appellate Authority, as such, this request of appellant is treated as Second Appeal.
3. Acceding to the request of appellant, her complaint case been converted into appeal case. Accordingly, the notice of hearing was issued to the parties for 06.10.2022. The case has been heard today in the Commission's office at Chandigarh.

5. Neither the PIO O/o Estate Officer, Jalandhar Development Authority, Jalandhar has come present to attend the hearing in person before the Bench or through cisco webex nor any intimation has been received from the PIO to this effect.
