**ORDER**

1. This order may be read with reference to the previous order dated 06.12.2022 passed by this Bench on the previous hearing..
2. The appellant Shri Rohit Sabharwal or his representative Ms. Sukhjinder Kaur have not come present to attend the hearing either in person before the Bench or through cisco webex.
3. Neither the PIO O/o GLADA, Ludhiana has come present to attend the hearing in person before the Bench nor through cisco webex. However, an e.mail dated 24.01.2023 has been received from the APIO-cum-AEO, GLADA, Ludhiana stating that the appellant did not visit office of GLADA for inspection of records.
4. The representative of the appellant Ms. Sukhjinder Kaur is contacted on mobile phone. She states that due to ill health, the appellant could not visit office of GLADA for inspection of records and she is not authorised to go for inspection of records.
5. The Bench, on perusal of case file, observes that the appellant has been supplied information on various dates as mentioned in the order dated 14.11.2022 and as such, is convinced that adequate information stands supplied to the appellant.

Notwithstanding the aforesaid, the Bench directs the PIO to file an affidavit on e.stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in appeal case No.1766/2021 stands supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

7. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the parties.
